

Use of Participant Material Consent Form

Photographic / Video / Audio / Written Material Release and Consent

This form is used to gain consent (including parental consent for persons under 18 years of age) for the Beacon Foundation to capture and use photograph/video/audio recording of individuals attending/participating in Beacon Foundation events/activities. It is also used to gain consent for transcriptions and use of written materials about the participant and their involvement with the Beacon Foundation.

2. Photographic/video/audio/transcriptions/written materials release

I authorise The Beacon Foundation (and its representatives, officers and employees acting with its permission or authority) ("Beacon") to take and use, distribute, exhibit, publish, reproduce, broadcast, communicate and adapt any photographs, video or sound recordings of me/the child as well as transcribe and write information about me/the child and your/their involvement with the Beacon Foundation ("the material"). The material may be reproduced or adapted either in full or part, with any wording or drawings, without any restriction or limitation in perpetuity. The material may be used in publications, promotional material (advertising and marketing), productions or presentations, websites (including but not limited to Beaconfoundation and eBeacon), social media pages (including but not limited to Facebook, Instagram and Twitter), print advertising, television advertising and reports and publications for external stakeholders ("a Beacon Foundation publication"). I acknowledge that I have/the child has no rights, at law or otherwise, in the material or in any Beacon Foundation publication that includes the material.

3. Authorisation

I authorise Beacon to take the actions described above. By signing this release and consent form, I confirm that:

- I am over the age of 18 years or am the parent/guardian of the above named child (if applicable);
- I consent and agree to Beacon doing the above for the purposes outlined above;
- I consent and agree to Beacon permitting its partners and sponsors using the material to promote Beacon and their association with Beacon;
- I agree that the material may be altered, distorted or blurred for design purposes;
- I agree I/the child will not receive any compensation from Beacon for any use, distribution, exhibition, publication, reproduction, broadcast, communication or adaption of the material in any of the ways outlined above;
- I waive any right or claim I/the child have or might in future have to any fee, royalty or other benefit to which I/the child might have otherwise been entitled in relation to any of the acts outlined above; and

- I consent to Beacon (or others) dealing with the material in such manner as Beacon may decide and without consultation with me/the above named child.

I acknowledge that, in consideration of my consent and agreement, Beacon agrees not to sell the material or use it in a manner which it deems to be adverse to me/the above named child.

4. Important information for participants

What is this consent for?

This consent form, when completed and signed by the participant, and, where the participant is a child, the participant's parent or guardian, will authorise The Beacon Foundation to use any photograph, video footage or sound recording of the participant in any Beacon Foundation publications, including websites and social media, as described in more detail above. It is also used to gain consent for transcriptions and use of written materials about the participant and their involvement with the Beacon Foundation.

Who should sign the consent form?

The participant should sign the form, and if the participant is under 18 years of age, the participant's parent or guardian must also sign the form. While The Beacon Foundation will make all reasonable efforts to ensure that only appropriately authorised persons complete the consent form and sign the authorisation in section 3, The Beacon Foundation will not be responsible for circumstances in which it was misled as to the identity and authority of that person.

What happens to the consent form once it is filled out?

The consent form will be placed on file and retained by The Beacon Foundation. If requested, a photocopy of the form will be made available to the participant and/or the participant's parent or guardian.
